(GRADE MARES WILL NOT BE ACCEPTED) to the stallion, Colonel Frenchman, cooled semen for the 2024 breeding
season (STARTS February 1st AND ENDS JUNE 28th).

-The STALLION FEE is \$1,500 (This includes the \$300 Booking fee) the remaining Breeding Fee is due BEFORE ANY SEMEN WILL BE SHIPPED. A copy, both sides, of your mare’s registration papers must accompany this completed, signed contract and booking fee. The owner recorded on the registration certificate will be the owner recorded on the Stallion Breeding Report. COPY OF MARE’S PAPERS & THE FIRST 3 PAGES OF THE SIGNED CONTRACT MUST BE MAILED OR EMAILED, BOTH ARE LISTED ABOVE. THE BOOKING FEE & BREED FEE MAY BE SENT BY ANY OF THE PAYMENT OPTIONS LISTED BELOW.

-SEMEN FEES/REQUESTS & PAYMENTS:

Collection days are Monday, Wednesday, and Fridays until the end date of June 28th 2024, which is his last collection date for the year of 2024. Cooled Semen charge per shipment: \$350. The mare must be on the books 24 hours prior to the collection day and MUST confirm at 8am Mountain Standard Time the day of collection. If you are not on the books 24 hours prior to collection day, books are full for that day, you have not confirmed before 8 am MST the day of collection semen will NOT be shipped. _____ (mare owner/agent agrees and understands, initial here)

- Before ordering semen, we highly recommend you have a cytology & culture performed prior to breeding your mare to make sure she is free of infections. If a 2nd semen shipment is needed, we WILL REQUIRE these two tests be done and results to be emailed to Stephanie at ruleperformancehorses@gmail.com before a 2nd semen shipment is sent.

_____ (Mare Owner/Agent to Initial Here). *Using the oxytocin protocol is also very beneficial with mares being bred via AI or having clearance issues. In our program we use 1cc IM starting 4 hours post AI then every 6 hours for 3.5 days with very high settle rates. We use this protocol on every single mare we own and breed.*

- This contract contains a “Live Foal Guarantee” which covers the first 72 hours after birth in the year 2025, after that we are no longer responsible so please insure foal with insurance of choice. A “Live Foal Guarantee” will apply only to those mares that are certified in foal by a licensed, attending veterinarian. Confirmation of such pregnancy in the form of documented ultrasound picture or letter from the attending veterinarian must be received by OCTOBER 1 of the breeding year or the mare will NOT be included in the Stallion Breeding Report.

-If the mare does not conceive, or deliver a live foal, during the contracted season the mare will have re-breeding privileges the following year only and will be subjected to a rebreed fee, so it is in your best interest to try and get mare settled in the original contracted year. The Stallion Owner/Manager may approve a substitute mare to use the re-breeding privilege. A substitute mare, accepted by the Stallion Owner/Manager, may be used ONLY if the original mare is deceased or deemed unfit for breeding by an accredited veterinarian. If the mare owner fails to re-breed the following year after the original contracted season, then any and all fees become forfeited; and the right to re-breed is canceled and the stallion owner is released from all further obligation of this contract unless otherwise agreed in writing & signed by both parties. IF YOU DO NOT ATTEMPT TO BREED IN THE 2024 SEASON THE CONTRACT WILL NOT CARRY OVER. _____ (Mare Owner/Agent to Initial Here)

-A Breeder's Certificate will be issued for the foal conceived because of the breeding. The Breeder's Certificate will be issued only after all expenses have been paid in full and after the foal is born and has been reported to the Stallion Owner/Manager. After mare is confirmed in foal, your vet or you MUST report back to stallion owner with mares name and breeding date(s) or your mare will not be listed on the Stallion Breeding Report. If said mare ends up being in foal and failure to notify stallion owner of pregnancy happens, the mare owner will have to pay a late fee of \$50 per mare.

-Stephanie Bake, Rule Performance Horses, Outback Stallion Station, nor any of its members or employees shall be liable for damages as a result of damage to the semen or as a result of the mare failing to settle. Stephanie Bake sole liability under this contract is in the event the stallion should die or become unfit for breeding purposes this contract shall terminate. NO REFUNDS GIVEN ON ANY FEES ASSOCIATED WITH THIS CONTRACT THE MARE OWNERS OPTION IS CHOICE OF ANY OTHER STALLIONS OWNED BY RULE PERFORMANCE HORSES TO CARRY OUT THIS CONTRACT _____ (Mare Owner/Agent to Initial Here)

-When signed by both parties this document will become a legally enforceable contract, binding upon both parties. In the event that there is any dispute, all disputes of every kind between the parties to this agreement shall only be submitted to arbitration and any award made by the arbitrators shall be considered final and binding. This contract is non-transferable and cannot be sold.
